

## **General Online Payment Policies**

### **OCTM Return/Refund Policy**

OCTM membership and conference/professional learning experiences are intangible and thus not returnable. However, see the Conference/Event Registration Policies below for information about how to obtain refunds prior to events. If you wish a refund of OCTM membership dues, a request must be submitted by e-mail within three days of payment to the OCTM Executive Director at [kim.yoak@ohioctm.org](mailto:kim.yoak@ohioctm.org) . After three days, all membership payments are non-refundable unless they are paid directly as part of event registration (see below).

### **Methods of Payment**

OCTM accepts checks (make payable to OCTM in \$USD), purchase orders, money orders, and credit cards (Visa, MasterCard, American Express, or Discover).

### **Purchase Orders**

If you need to pay membership dues or event registration using a purchase order, please send a scanned copy of the completed membership application or event registration form, along with your signed purchase order, to the contact e-mail address or mailing address listed on the form. Note that this contact e-mail or mailing address may vary depending on the event; please read the form carefully.

### **Order Confirmation**

Your online order will be acknowledged by electronic mail. Included in this message will be the estimated cost of the order. Please be sure to include a correct e-mail address, or you will not receive a confirmation.

### **Sales Tax**

OCTM is a non-profit 501(c)(3) organization and thus does not pay or charge sales tax.

### **Shipping & Handling**

OCTM has no shipping and handling charges. Membership cards will be sent in U.S. Mail to the address that you provide. Most event materials will be provided at the event in person

or before the event via e-mail. Other documents related to membership or event registration may be sent to your mailing address or e-mail address.

### **Can I register a group?**

No. All participants must register individually. However, we can accept payment for multiple participants at once via check or purchase order; please read the payment information for the specific event for where to send the check or purchase order.

### **How do I register if I am a speaker at the annual conference?**

Lead speakers may register as lead speakers on the event registration website, and your registration for conference will be waived. Your status as a lead speaker will be verified by our Conference Coordinator once you have registered.

### **Are there alternatives to online registration and/or payment?**

Registration and payment are also available by mail or email. OCTM accepts Visa, MasterCard, American Express, Discover, checks, money orders, and purchase orders. All payments must be submitted in U.S. dollars and drawn on U.S. bank accounts, money orders, or credit cards. Credit card payments will be subject to the appropriate exchange rate. ### **How do I cancel a registration? Do I get a refund if I cancel my registration?**

- Cancellation requests must be received in writing by the event registration contact, at least three weeks before the start of the event. When a request is received before this time, OCTM will issue a full refund minus a 10% cancellation fee.
- Refunds will not be granted if requests are received within three weeks prior to the event.

- Memberships that are received as part of non-member (with membership) registrations will be cancelled with cancelled registrations.
- Substitutions will be accepted via email, letter, and onsite registration. Substitutes must submit a letter explaining who they are substituting and must return the original attendee's badge. Non-members substituting for members will be charged the current non-member registration rate. In addition, no discount will be given for members substituting for non-members.
- Refunds will be issued within eight weeks after the event.
